- B. Current Legislative and District Initiatives: Superintendent Cassidy shared information on recent district initiatives and legislative action.

Legislative Updates:

The Senate convened on Tuesday and passed their substitute version of SB 911. The bill now moves back to the House for their concurrence with the substitute version. This bill would do three things (unchanged from my last update):

- 1. Eliminate the floor funding provision
- 2. Cap the liability rate that school districts pay for MPSERS at 15.21%
- 3. Eliminate the 3% that employees pay for retiree health insurance

It is the third provision that could still see some more modification. The current version has employees cease paying the 3% on October 1, 2025, a year from now. The House could modify this

date during their session next week to possibly end the 3% payment on either April 1, 2025, or July 1, 2025. This House will act on this next Wednesday.

It is predicted to be slow in Lansing over the next few months. However, there are rumors of a new version of the dyslexia bill moving through the House. We will keep an eye on this to better understand details.
